I. NAME

IV. LIMITATION ON CORPORATE ACTIVITIES


A. This corporation is organized and operating exclusively for charitable purposes within the meaning of Section 501(c)(3), Internal Revenue Code.

B. No substantial part of the activities of this corporation shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation, nor shall this corporation participate or intervene in any political campaign (including publishing or distribution of statements) on behalf of or in opposition to any candidate for public office.

V. DEDICATION AND DISSOLUTION


The property of this corporation is irrevocably dedicated to public and charitable purposes and no part of the net income or assets of this organization shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which has the purpose of providing education to children within Merced County and which is organized and operating exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3), Internal Revenue Code.
